Thank you for your interest in participating in the Law Enforcement Exploring Academy 2010. In order to accommodate as many Explorers as possible and to encourage post participation there are several items listed below to keep in mind. Please note the following:

- There will be a cap on the number of teams allowed to participate. This number will be dependent upon how many posts volunteer to help and the number of scenarios we will be able to run.
- Posts will be allowed to register up to 4 teams per day to begin with. If space allows, additional teams may register and those posts will be put into a drawing and selected at random.
- A team will consist of no less than 2 people and you will only be allowed to register one team with 2 people.
- All posts running a scenario or helping with the event in some way will be allowed to pre-register. Pre-registration begins now and it has not been determined when it will end.
- If you are interested in helping with the event in order to secure your post a spot, contact Scott Whiteford at swhiteford@ci.plymouth.mn.us. To the right of this information are the posts who have contacted us about helping. If you have offered to help and do not see yourself on the list, or if you have helped in the past and would like to help again, contact Scott.
- All registration will close on March 17 so we have time to put the schedule together. All teams must be PAID in order to guarantee their spot. You can register your teams without payment but payment must be received by March 17 or they will not be added into the schedule.
